

## To Your Health — Medical Compliance

In a recent report from the CDC, medication adherence is a problem across all ages and socioeconomic levels.



Among children under age 12, less than 10% have used 2 or more prescription drugs in the past month, with only 1% using 5 or more drugs. However, among adults 60 years of age and older, more than 76% used 2 or more

prescription drugs, and 37% used 5 or more drugs. Women were likely to use more medications than men.

In Massachusetts, in the course of 1 year, 22% of prescriptions were never filled, and of first time prescriptions, 28% were not filled. Non-adherence to medication regimens is estimated to add \$300 billion in costs to the health care system annually, as well as the negative impact it has on patients' health outcomes and quality of life.

Why don't people fill and continue to use the medications prescribed for them? One possibility is that when a health problem causes few or no symptoms, such as elevated blood pressure or cholesterol, the patient may not see the need for the medication. Cost could also be an issue, particularly if the person is unsure why the drug is prescribed. Even with health insurance, co-pays may be high. And of course, we're all human and sometimes just forget to take our medicine.

How can we make it easier to take medicine and increase compliance? Patients are more likely to fill their prescriptions if the physician sends it directly to the pharmacy. I recently read that 55% of physicians have adopted electronic medical records which should increase

e-prescribing. Pharmacies often will notify you when your medicine needs to be refilled. On a personal level, putting your medicine in a weekly/monthly pill box will ensure that you know if you've missed a dose.

If you're having trouble paying for your medicine, there are some programs to help. Many pharmacies and grocery stores now have very low to no-cost generic medications as well as lower cost mail-order services. Pharmaceutical companies often have special programs to help low-income individuals with their costs, and some companies offer discount cards to limit co-pays. Some people have been able to order their drugs from other countries. I often see advertisements to order prescriptions from Israel.

Of course, the Health Care Initiative is supposed to eliminate the infamous "doughnut hole." If you find yourself unable to afford your medication, make sure your physician knows. Many times, they have no idea how much a medicine costs and can perhaps prescribe an effective alternative. In an emergency, doctors have samples of some medications that can be used short-term.

The fact is that people are more likely to fill a prescription for antibiotics than for blood pressure medication. Yet in the long run, the blood pressure medicine is probably more important for your health. To help you remember to take your medicine, make it as easy as possible for yourself. If possible, have your pharmacy place you on auto-refill with automatic delivery and payment by credit card. Put your medicine in a pill box and put that box where you will see it. Make it a habit to take your medicine at a certain time each day. We are living longer and healthier, and some of that is due to medication use. Keep up the good work.

While there is often much debate about the sincerity of their support, it is important to know that the American public and the United States Congress are overwhelmingly pro-Israel, and we must continue to be diligent in our efforts. We need to continue to oppose all calls for divestment in Israel and with companies who do business with Israel. The greatest threat to Israel, and probably the free world, is Iran's quest for nuclear weapons. Currently our best response is to continue to urge support for Iran sanctions at both the State and Federal levels. LET'S KEEP UP THE GOOD WORK.


## November Election

Voter registration and turn out are at an all time low, even among the Jewish community. Many say that it is because there is nothing to vote for or that they feel their vote doesn't count. We need to get out and vote in spite of carpools, work, rain, and lots on our plate. No matter how you vote, remember to vote! In Maryland there will be two important initiatives on the ballot and here your vote could make a difference.

The first is to repeal the Same-Sex Marriage Act passed

by the recent session of the General Assembly. Those in the faith community, including many in the Jewish community, view it as a religious freedom issue and claim it allows the government to support a "questionable" or "undesirable" life style. It does not mandate that any clergy perform a same-sex ceremony. You are not legally married just by a religious ceremony. The clergy must also be licensed by the State. This legislation only addresses civil marriage. The polls show this issue to be very close so be sure to vote how you feel. IT WILL MAKE A DIFFERENCE..

The second issue relates to casino gambling. The General Assembly in Annapolis will determine what will be on the November ballot. It will look to expand casino gambling by adding a downtown casino and allowing table games in addition to slots. The organized Jewish community feels that they cannot publically support gambling so they take no official position on the issue. From an economic perspective, some feel that additional casinos will reduce the revenues of existing casinos. For many the real issue is the addition of table games because as many believe that's where the real money is and available now in surrounding states. If we are to be truly competitive and economically viable, table games are a must. Also it is important to ensure that tax payers get their fair share of the revenues. MAKE YOUR VOICE HEARD NOW.... Our honoree, Linda A. Hurwitz, exemplifies the leadership skills that are Federation's hallmark. Congratulations, Linda, upon receiving the E.B. Hirsh Lifetime Achievement Award.


