To Your Health - Salt in the Wound

When I was in medical school, anyone with any heart ailment was placed on a reduced salt, 2-gram sodium diet.



I remember the bitter complaints we got from our patients that the food had no taste. It therefore came as a surprise when The 2010 Dietary Guidelines for Americans recommended a daily sodium intake of 2300 mg (2.3

grams) for the general population and 1500 mg for individuals 51 years of age and older African Americans; and individuals with hypertension, diabetes, or chronic kidney disease. The American Heart Association recently recommended that all Americans consume no more than 1500 mg of sodium per day.

Are these current recommendations an unjustified target that just makes everyone's life miserable, or is this a valid attempt to alter food culture and provide future generations with a low-sodium environment that reduces

the risk of hypertension and cardiovascular disease?

At a recent meeting on hypertension, one presenter noted that less than 5% of individuals consumed less that 2300 mg of sodium a day. International surveys showed that the mean sodium consumption was 3700 mg per day, with China taking in the most, at 5000 mg per day.

Despite there being very little change in sodium intake over the past 50 years, the incidence of stroke has declined 70% in the US. Although high levels of sodium intake have a larger effect on systolic blood pressure, typical consumption only has a small impact. On the other hand, individuals who consumed more than 4000 mg per day of sodium had more that double the risk of stroke compared with those who consumed less that 1500 mg. Analyses that compared moderate vs. low sodium intakes found no increased risk with individuals consuming moderate amounts.

So, as we always say, everything in moderation. We should be setting a good example for our children so they do not become dependent on high-salt intakes.

Now that the High Holidays are behind us, I reflect upon the issues of the day in my organizational and community life as a Jewish American woman. Following are some of the issues that I believe will be important for us in the coming year.

Voting — This is the most basic right of every citizen, and the United States has long been an example for the entire world. The Constitution allows the states to determine qualifications for voting. Amendments to the Constitution such as the Nineteenth Amendment, which gave women

the right to vote, and others which prevented minorities from being denied the right to vote, seemed to provide a basic standard for all states.

Of great concern is the recent Supreme Court decision that eliminates checks on states that want to restrict voting. No one knows how this will affect voting in each

state, but we will monitor the results and keep you informed.

Health Care — As the "Affordable Health Care Act" moves toward implementation, we are all concerned how it will affect us personally and as a community. Will Medicare be compromised and will we all pay more for less access and lower quality? Can Congress repeal all or part of the Act, and will it make a difference? Will the needs of women be ignored, especially the public policies that attempt to regulate their reproductive health? Will lifesaving, advanced medical research, especially gene therapy and "stem cell" be put on hold because of funding and politics? We must be informed and "speak up" now. YOU CAN MAKE A DIFFERENCE

Domestic Violence — Although there is more information available today than ever before and the Federal "Violence Against Women Act" was reauthorized, women at all levels of society, including the military, continue to be abused physically and mentally without adequate resources and help. We must support stronger laws and penalties for the abuser, while educating law enforcement that rape is a violent crime, not a sexual act. YOU CAN MAKE IT HAPPEN...STAY INFORMED......

Pay Equity and Economic Security — Although Congress has passed excellent legislation trying to improve pay and job equity for women, they still earn less than men and make up two-thirds of minimum wage employees. We need to reaffirm pay equity policies that reduce the gender wage gap and expand support for anti-discrimination

policies to include pregnancy as well as for family and medical leave, which allow employees to earn paid parental, family, and sick leave. It is also important to

structure minimum wage increases that account for inflation and the cost of living. However, if these policies are to be realistic, we must be sensitive to the needs of the

business community, especially small business, and work as partners to find equitable solutions. MAKE YOUR VOICES HEARD.....

Israel — We are very fortunate that there is much support for Israel in the Congress of the United States and by the American public. There is growing concern in the Jewish community that there is less support in the Administration and by President Obama, although the recent involvement of our Secretary of State John Kerry in the "peace process" seems to be a real plus. I believe that our role as American Jews is to show our government that strong support for Israel is vital to peace in the Middle East. I also believe that while we may debate the policies of the Israeli government in our organizations within our community, we must present a united message for the State of Israel and its right to exist and protect itself and its citizens. STAY INFORMED..FEDERATION WILL LEAD THE WAY....... La Shanah Tovah.

Chanukah and Thanksgiving: A Once in Eternity Overlap! Turkey and Latkes?

This year features an anomaly for American Jews — the first day of Chanukah coincides with Thanksgiving on November 28, 2013. It turns out that it has never happened before, and it will never happen in our lifetime. Imagine, **Turkey and Latkes!**

Thanksgiving is set as the 4th Thursday in November, meaning the latest it can be is November 28th. November 28th is also the earliest Chanukah can be. The Jewish calendar repeats on a 19-year cycle, and Thanksgiving repeats on a 7-year cycle. You would expect them to coincide every 133 years. The last time it would have happened is 1861. However, Thanksgiving was only formally established by President Lincoln in 1863. So it has never happened before.

Why won't it ever happen in our lifetime? Because the Jewish calendar is very slowly getting out of sync with the solar calendar at a rate of 4 days per 1,000 years. (Not bad for a many centuries-old calendar!) This means that over the years the calendar will drift forward so that the earliest Chanukah will be is November 29. The last time Chanukah will fall on November 28th will be in 2146, which happens to be a Monday.

Of course, if the Jewish calendar is never modified in any way, then it will slowly move forward through the Gregorian calendar until it loops back to where it is now. So, Chanukah will again fall on Thursday, November 28th in the year 79811. When that happens, I'll refer you to this 2013 article!

So on November 28th, enjoy your turkey and latkes. It has never happened before.
