

# Message from our President Sheila K. Derman



MAN (WOMAN) PLANS AND G-D LAUGHS....How appropriate is this ancient saying to describe my two years as your President, an honor and a challenge beyond words. I had many wonderful plans to celebrate becoming 100 years old. Then the ultimate challenge—the death of my beloved husband Paul and the illness of my son put

everything in a new perspective. Plans changed but in a few days we WILL be celebrating our 100 years in a day filled with excitement and fun as we relive what we were and envision what we will be. I learned that today's Federation woman is not only a leader but also a friend in every way and who provides not only support and comfort but also takes over to get the job done, as we did after the untimely death of Hortense Moses in 1924. As we dug through our archives of 100 years, I learned that our women 100 years ago had vision and skills to solve the problem of the day: "How to bring the different Jewish women in Baltimore together (literally the *uptown* and the *downtown*) for education, advocacy and calendar conflicts." So it began in 1916 as Jewish women from over 40 diverse organizations came together and were instrumental in achieving Women's Suffrage (The Right to Vote for All Woman).

WHAT A START.....We have continued to bring together Orthodox, Conservative and Reform women from Sisterhoods to

workers guilds to study groups to major organizations like Hadassah and NCJW, creating dozens of resolutions through the wars and the Holocaust, supporting hundreds of immigrants from Europe and the Soviet Union and supporting the state of Israel. We came to learn about each other, such as our program this past January about the differing role of the Mikvah in the lives of Orthodox, Conservative and Reform women. We educated our constituents about domestic violence (in the Jewish community, too) and domestic human trafficking in our own backyard. Now, more than ever in this troubled political climate, we must stand up and speak out for women as we did in 1920. We must empower today's woman by the passage of laws that provide financial equality through workplace fairness and pay equity and give every woman the right to make health and reproductive decisions in her life without government interference.

My two years as your President may have been different than I planned but they were wonderfully filled with accomplishment ready for our next century. There are not enough words to thank everyone who not only SHOWED UP but also worked together, taking over when necessary to MAKE IT HAPPEN. I know that a strong groundwork has been laid for Helene Waranch and her officers. I can't wait to see what they accomplish. SHOW UP WITH ME INTO OUR NEXT CENTURY.

We began the day with a tour of the Maryland State House, viewing the historic rooms and the legislature in session. In honor of Federation's 100<sup>th</sup> year, Delegate Shelly Hettleman introduced our group as we sat in the gallery. Pictures were taken of us all on the floor of the delegate chamber. Then we proceeded to a hearing room in the nearby legislative office building to visit with many of our local lawmakers. Dana Stein, Dan Morheim and Shelly Hettleman were some of those who talked with us.

At lunchtime, we proceeded to the campus of the US Naval Academy to visit the Commodore Uriah P. Levy Center and Jewish Chapel and to enjoy a delicious meal. David Hoffberger, director of the Center, welcomed us and gave us a full history of the Chapel and building. During lunch we had the privilege of hearing from a delightful young Jewish woman in her second year as a midshipman. She talked about her background, her life at the Academy and her desire to become an astronaut. We also learned about the many activities that the Center offers. We then had the opportunity to spend time in the most impressive Jewish chapel. What a fun and informative day!

At Passover, while we were celebrating with family and friends, we did not forget our Jewish servicemen and women who are far from home, protecting us throughout the world. # Maryland Healthy Working Families Act Earned Paid Sick Days

As always, the legislative session of the Maryland General Assembly this year ended with the feeling of "WIN SOME—LOSE

SOME." The results of our advocacy efforts on behalf of women's issues produced a mixed bag of results. Bills which passed included: the expansion of Equal Pay for Equal Work, the expansion of grounds for relief in Peace Orders, the extension of domestic violence law to

include stalking and harassment and a new bill devised to close the gaps in contraceptive insurance coverage. These bills now go to the Governor for a signature or a veto.

Bills which failed included ending parental rights of rapists, expungement of certain convictions of victims of human trafficking and the immediate transfer of firearms to police after an issuance of a

domestic violence order. In my opinion, the failure of these bills shows a real almost inbred disregard for the legal rights and needs of women to protect

so-called civil rights of others, mostly men. The need for the passage of this legislation will not go away. We must work very diligently and smartly to show that women's needs are a priority.

Also failed were the Earned Sick Leave Bill and the Fair Scheduling Act of 2016. Senate

President Mike Miller has said that the leadership may call a one-day special session to take up the Earned Sick Leave Bill as well as a tax relief bill, which ran out of time.

As you can see our work as advocates is never ending. We must stay informed and vigil, ready to act. FEDERATION WILL LEAD THE WAY!
