Review of our Opening Meeting

On September 30, 2021, our Federation had their opening meeting. Due to the continued Covid problems, our meeting was held via Zoom. Helene H. Waranch, past president, introduced the featured speaker, Lauren Hogan, Managing Director of Policy and Professional Advancement of the National Association for the Education of Young Children. The topic of her presentation was "Child Care and COVID: The Challenges, The Opportunities and What You Can Do To Help."

Ms. Hogan stated that child care needs to be affordable and high quality, but is not at present. She noted that currently child care workers are paid very low wages which makes it a difficult job for women to stay in. She added that the COVID pandemic caused closures of many child care programs and forced women in particular out of the workforce. The pandemic may also have created opportunities by infusion of funding and increased awareness of the need to change the status quo. Ms. Hogan emphasized the importance of advocacy through sharing personal stories and experiences, going to meetings, researching and contacting local officials, joining NAEYC and staying informed. She noted that the military has developed an exemplary child care model. She provided us with web sites and information as to how one can be an advocate for both early childcare and education. Following a Q & A opportunity, Marcia thanked Ms. Hogan for her important presentation and noted that she will be posting the video of her talk online. Helene H. Waranch recommended that one resolution for the Annual Convention address early childhood education. Our Social Action project for this program was buying new school supplies for Fallstaff Elementary and Middle Schools. It was a very successful and informative opening meeting of our Federation.

Federation Legislative Update—2021-2022

Did You Know That:

According to the Census, the United States has 23 million more people than 10 years ago. More than 1/3 of the nation now lives in counties where people of color are a majority. More Americans who previously identified as white are now choosing more than one race. Forty percent of the total population now identify as multiracial. A majority of the total population now identify as multiracial. More than 128,650 Marylanders self-identified as American Indian or Alaska natives. Prince Georges County has a larger population than five U. S. States.

Maryland is one of only 14 states that allow children under 18 to get married. The current law in Maryland is age 15. If married before 18, they are unable to file for divorce until 18. Maryland has become a destination state for people from other states. For seven years advocates have tried to raise the age to 17 (a compromise). Another try is scheduled for next legislative session.

The United States spends 0.2% of its Gross Domestic Production (GDP) on children under 2 years old. Typical parents of 2 year olds in Denmark pay no more than 25% of the cost of care, which averages \$200. The U.S. average cost for day care is \$1,100 per month.

In September the President raised the cap on refugees' admissions to the United States to 125,000 for the next 12 months. Before the U.S. withdrawal from Afghanistan,

there were already 82.4 million displaced refugees in 2020. The current Administration has revised the food stamp program's nutritional standards and increased monthly benefits per person by 25%, affecting 42 million people. In October, the Department of Health and Human Services revised the restrictive Title X requirements that resulted in the State of Maryland and the City of Baltimore refusing to take restricted federal funding.

Mitch McConnell has voted 32 times over the years to raise the debt ceiling but recently voted not to raise it.

Between January and June of 2021, 13,000 men entered the workforce, while the number of working women fell by 57,000.

Maryland's bus industry employs 2,749 people but indirectly supports 39,000 additional jobs.

Hospitals in Maryland employ 107,000 people.

Just 40% of the top-paying jobs in Maryland state government are held by women.

Outdoor recreation in Maryland accounts for 89,000 jobs and puts \$7 billion in the state's economy. The Department of Natural Resources and the Governor have created a new Office of Outdoor Recreation.

The Maryland General Assembly session starts on January 12th. Final Filing date for candidates for the 2022 election is February 22nd. The Primary Election is June 28th. The General Election is on November 8th. Remember to vote!!

Utilizing community resources such as volunteer tutors and mentors, referrals to community partners such as JCS, CHANA, Chai Lifeline and others, Shalom Tikvah creates a 360 degree system of individualized support for each family. Dr. Nicole Glick and Jennifer Grossman are the founders of Shalom Tikvah. According to an article from JMore in 12/13/2019—"There are so many barriers when it comes to mental health care, and we strive to take down those barriers," says Jennifer Grossman, Shalom Tikvah's co-founder. "Our families look like our neighbors or our children's friends' parents. These are good people in tough situations." Grossman, an educator who has extensive experience in the nonprofit world, and Dr. Nicole Glick, a licensed psychologist, founded the organization.
