Federation Legislative Update—2024

Maryland Legislative Agenda for Women (MLAW) Seven bills passed Maryland legislation in 2024.

HB 496/SB 758: Sexual Crimes-Definition of Consent and Repeal of Force:

Sex without consent is not enough to prove rape under Maryland law. This bill proposes a definition of "consent" under sex crimes laws and would strike "force or threat of force" as an element of second-degree rape.

HB 99-SB 113: Criminal Law-Sexual Solicitation of a Minor Through Child Pornography-Prohibition:

Expands sexual solicitation of a minor to include production of child pornography.

HJ 1/SJ 1: Affirming the Federal Equal Rights Amendment:

This joint resolution expresses the sense of the Maryland Legislature that the federal article of the amendment commonly known as "The Equal Rights Amendment" has met all Article V requirement for an amendment to the Constitution of The united States and is valid as the 28th Amendment to the Constitution of The United States and urges the President and Congress of the United States to affirm the validity of the Equal Rights Amendment and direct the Archivist of the United States to certify and publish the Equal Rights Amendment as the 28th Amendment without delay.

HB 39/SB 197: Residential Services Agencies-Reimbursement-Personal Assistance Services (Homecare Worker Rights Act of 2024): This bill will ensure that home care workers (84% of home care workers are women) who work for agencies that receive Medicaid reimbursements are not misclassified as independent contractors and therefore are entitled to overtime, sick and safe leave, unemployment insurance and worker's compensation.

HB 1091/SB 975: Public Safety-Reproductive Health Care Clinic Security Grant Program. (Abortion Care Access Grant Program and Fund)

HB 649/SB 525: Labor and Employment- Equal Pay for Equal Work. Wage Range Transparency:

This bill creates wage transparency by requiring employers to include pay ranges and a general description of benefits and other compensation in job postings, helping Maryland businesses

attract and retain talent, save time and resources, and address the gender and racial/ethnic pay gap.

HB 691/SB 119: Legally protected Health Care-Gender-Affirming Treatment:

Extend current shielding protections that protect reproductive health care to cover gender affirming care.

Vote YES to Question 1

Maryland voters will have the opportunity to cast their ballot on The Reproductive Freedom referendum on **Tuesday, November 5th.** A **YES** vote to Question 1 will amend Maryland's Constitution to ensure that everyone has the fundamental right to reproductive freedom, including the right to abortion access and birth control.

NOVEMBER MEETING WITH AIPAC

The Annual Federation's Fall Dinner Meeting looks to be a very special event this year. It will take place on the evening of **Thursday, November 14, 2024, at Har Sinai Oheb Shalom Congregation.**We are very excited to have as our guest speaker **Stephen Knable**, the Mid-Atlantic Regional Political Director of AIPAC.

As you may know, AIPAC, the American Israel Public Affairs Committee, is a bipartisan, pro-Israel political action committee, the largest pro-Israel PAC in America. Mr. Knable will brief us on how AIPAC will be working with our newly elected government officials following the November 2024 elections, in light of the turbulent times in the U.S. and the middle east.



108TH ANNUAL CONVENTION REVIEW





The 108th Annual Convention was held on May 16th at Har Sinai-Oheb Shalom Congregation with close to 300 attendees representing Jewish women's organizations from the Baltimore and Howard County areas. This is the highlight of The Federation's activities each year. The theme was: *Breaking Down Barriers to Combat Hate.* How pertinent and timely as we witness increasing antisemitic activities and crimes, and antisemitic propaganda across the globe. Our keynote speaker, *Meredith Weisel*, Regional Director for the Anti-Defamation League, provided a most interesting, informative and

enlightening presentation. Our business meeting included the release of outgoing officers and the induction of the new officers. We thank all our dedicated women who have served as past officers and welcome our new officers.

Helene Waranch reviewed our revised bylaws which were approved by the membership. Sheila Derman and Jo-Ann Orlinsky reviewed our 2024 resolutions; *New Issues in Women's Health, Antisemitism and Hate Activities*, and *Stand with Israel*. These were also approved by our membership. CeCe Rund gave her outgoing President's report and ushered in our new President, Shulamit Finkelstein. The coveted E.B. Hirsh Lifetime Achievement Award was presented to **Rabbi Nina Beth Cardin** by our co-chairs, Elissa Ness and Marcia Bornfriend. Rabbi Cardin is a community Rabbi who currently works at the Intersection of Faith and Sustainability and is President of The Baltimore Board of Rabbis as well as co-chair of the Jewish community's Baltimore Sustainability Network. Yaffa catered the lunch and we heard greetings from several of our state legislators during the meal.
